The renter signing this form accepts full responsibility for the safety and return of the equipment in the same condition it was received.

If the borrower wishes to return the equipment prior to completion of the contract there will be no refund for unused time. #### **ESSENTIAL NOTES:**

- 1. You can train as frequently or infrequently as you like. There are no minimums or maximums. NeurOptimal® does not push the brain, so you cannot over train. We encourage you to track shifts to determine a frequency that is useful or not useful to you.
- 2. You MUST connect the system to the internet weekly in order for the system to continue functioning. If you do not connect the system to wifi as instructed here, and you lose time with the system, you will not be granted additional days to the rental.
- 3. You MUST contact WFN if the system encounters difficulty in functioning. Once given instructions to fix any technical problems, if we do not hear from you in 24 hours, we will assume the system is functioning. You will not be granted additional days if you are unable to attend to the system in a timely manner.
- 4. Fees, completed contract, and consent form are due 24 hours prior to shipping. Acceptable forms of payment are cash, check, or credit card.
- 5. One-month rental equals 28 days. Rental period starts the day after receiving the equipment. Return shipping is on the 29th day.
- 6. If borrower returns the system after the due date, Whole Family Neurofeedback charges a rate of \$25 per day for the time overdue.
- 7. Failure to return the equipment within 15 business days following the termination of this contract will result in the borrower's credit card being charged at Zengar's professional pricing (currently \$10,495) as payment in full for the system. At this point, the borrower becomes a full legal owner of the license and equipment with all privileges thereto. These fees are separate and additional to the contracted rates above.
- 8. Regardless of how the client chooses to pay, the client must fill out the credit card section of this contract, so that Whole Family Neurofeedback has a credit card on file for the duration of the rental period. The deposit must be paid by credit card.
